NOTICE OF ELECTION

Notice is hereby given that:

1. Hon'ble High Court of Delhi vide Order dated 21.08.2019 in W.P.(C) 7445/2017, C.M. Nos. 31771/2019, 35587/2019 and 35591/2019 in the matter of "Sh K.M. Bhatnagar & ANR Vs Union of India & Ors.", has ordered that the election to the Managing Committee of Shri Sai Bhakta Samaj (Regd.), Delhi should be conducted on the basis of the last approved members' list comprising of 622 members, on the basis of which the last elections were conducted in October 2006.
